**INSTRUMENT OF RATIFICATION OF THE
CONVENTION ON INTERNATIONAL INTERESTS
IN MOBILE EQUIPMENT 2001**

Whereas the Convention on International Interests in Mobile Equipment was adopted by the Diplomatic Conference at Cape Town on the 16th of November, 2001;

And Whereas Nigeria is signatory to the aforesaid Convention;

And Whereas it is provided in Article 47 (2) and (4) of the aforesaid Convention that the Convention is subject to ratification by States Parties to the Convention, and that the Instrument of Ratification shall be deposited with the Depository;

And Whereas the Government of the Federal Republic of Nigeria has, by a decision duly reached in accordance with its constitutional provisions, agreed to ratify the aforesaid Convention.

Now Therefore, I, OLUSEGUN OBASANJO, President of the Federal Republic of Nigeria, on behalf of the Government of the Federal Republic of Nigeria, do hereby ratify the aforesaid Convention.

and Aircraft Protocol**
