#### Terrorist Bombings in London:

Invoking Rules 42 and 52 Senator Bassey Ewa-Henshaw invited the attention of the Senate to the recent terrorist bombings in London which claimed the lives of three Nigerians. He sought and obtained leave of the Senate to introduce a Motion on the subject as a Matter of Urgent Public Importance.

That whereas on Thursday July 7, 2005, the world woke up to a gruesome drama as it unfolded in the heart of London. Within a short space of time suicide bombers unleashed a deadly and horrifying campaign of terror on innocent and unsuspecting commuters as they jammed the London underground at the height of the morning rush hour heading for their places of work;

WHEREAS the first bomb exploded in the tunnel near Liverpool Street Station at about 8.50 a.m. The second bomb went off just seconds later at the Edgeware Road Station. By 9.15 am the third bomb went off at the Kings Cross Station and by 9.47 am Bus No. 30 exploded at Tavistock Square. So, Mr. President, Distinguished Senators, in less than one hour, three underground stations and a bus were bombed leaving over 50 people dead and more than 700 injured. Indeed, the death toll has risen to 56 as more critically injured people have given up. Sadly, the fatalities cut across numerous nationalities including Nigeria. We lost three Nigerian lives which included 26 year old Anthony Fatayi-Williams, the grandson of Nigeria's former Chief Justice, Atanda Fatayi—Williams;

WHEREAS Anthony Fatayi-Williams was cut down in his prime with a promising career ahead of him in an oil servicing company. I attended the funeral of this young Nigerian in London last Saturday, July 23, and I saw his devastated parents and a large congregation of mourners of all nationalities overwhelmed with grief. It was for me a traumatic experience. But even more appalling was the fact that as Anthony was being buried on that Saturday, suicide bombers were creating another carnage in an Egyptian resort Sharm-el-Sheik. They left 88 people dead and hundreds injured. Two days earlier, on Thursday, July 21, exactly 2 weeks to the day of the first bombings, another set of 4 bombers unsuccessfully tried to detonate their deadly cargos again in London; WHEREAS from Nairobi to New York, to Madrid to London to Sham-el-Sheik, as the list of cities continues to grow and the phenomenon becomes global the number of innocent lives lost continues to increase. But, why? Why are innocent people being slaughtered like this in their hundreds? People who have no hand in any government policy or action. Nigeria is neither fighting in Iraq nor is in any way involved in any of the Middle-East conflicts. So, why was Anthony Fatayi-Williams and the other Nigerians murdered? Ironically also people who are opposed to their governments policies and involvements in the Middle East will always be among the causalities in this type of indiscriminate massacre;

WHEREAS the wanton destruction of innocent lives must be condemned in the strongest terms possible, because no policy decision or action by any individual, group or government can justify it. The killing of innocent people is both callous and ungodly; and

WHEREAS having said that, I need also to add that there is an African proverb which says that while you chastise the kite for preying on the chick you must also advise the chick to watch its steps. There is need for all those governments whose policies and actions (in the Middle East and elsewhere) are generating this level of hate to re-examine such policies and actions. Those who live by the gun die by the gun. Violence begets violence and hatred begets hatred. It should by now be obvious that violence and force solve nothing. They only make matters worse. As the world marks the 60th anniversary of the dropping of the atomic bomb on Hiroshima and Nagasaki those who claim leadership of the world must find the courage to acknowledge that fairness, understanding, tolerance and respect are the essential ingredients for a peaceful safer world.

- (*ii*) That the Federal Government of Nigeria be requested to take urgent steps to assure the safety of all citizens and residents and forestall the possibility of such an occurrence within our borders;
- (Hi) That this distinguished Senate convey to the British Parliament through the British High Commissioner to Nigeria the sincere condolences of the Senate of the Federal Republic of Nigeria over the events of July 7, 2005 and the loss of lives involved; and
- (*iv*) That this distinguished Senate make a special appeal to all governments whose policies and actions in the Middle-East and elsewhere are responsible for generating a high level of hate and bitterness to re-examine such polices, including the use of force, and seek ways to promote equity and fairness for all people for a more peaceful world order (*Senator Bassey Ewa-Henshaw*).

Committee, by leave of Senate granted additional four weeks extension to enable it concludes the assignment and report to the Senate.
